A. REQUIREMENTS TO INTRODUCE SMALL ANIMALS (dogs, cats, ferrets) to Panama.

- Vaccinated for rabies and dated for dogs/cats three (3) months of age and older, thirty days (30) days prior to shipment.
- Declaration of day of vaccination, brand, expiration and code of the immunogen.
- Vaccinated for rabies and dated for ferrets 14 to 16 weeks of age, thirty days (30) days prior to shipment.
- Small Animals (dogs, cats, ferrets) were examined and in good health.
- Declaration of endo and ecto dewormers did it thirty days (30) days prior to shipment.

Dogs: Rabies, Distemper, Hepatitis, Leptospirosis, Parvovirus.
Cats: Rabies, Viral feline Rinotraqueitis, Feline Calciavirus, Feline Panleucopenia.

Health Certificate for Exportation for Small Animals (dogs, cats, ferrets) shall have been legalized by the Apostille of the recognize authority or authenticated by the Panamanian Consulate from the country of origin.

Fees to be paid:

- \$6.00 (dollars) for the Phytozoosanitary Certificate of importation. One for each animal.
- \$.10.00 (dollars) for the veterinary inspection

Schedule: 24 horas

**Ministry of Health/Departament of Zoonosis
Control/Health Quarantine**

Fee to be paid:

- \$.130.00 (dollars) for home pet quarantine, for each one

Schedule:

Monday to Sunday: 7:00-23:00

I. B. Proceedings of the paperwork for quarantine

Receipt of the expective arrival of the pet(s) three (3) days prior to entry, with completed Quarantine Request. It can be downloaded from the [website-www.minsa.gob.pa](http://www.minsa.gob.pa), icon “**ZOONOSIS**” at the end of the page and sent to: cam@minsa.gob.pa/dcontreras@minsa.gob.pa
